4. I hereby represent that my dog(s) is of good health and has not been ill with nay known contagious diseases within the past 30 days.
5. I recognize that the health of the dog(s) is the owner's responsibility. I hereby represent that all required vaccinations (rabies, bordetella, distemper and parvovirus) are up to date. I will also continue to ensure that the required vaccinations will be kept up to date for as long as my dog(s) attends Happy Tails Doggy Daycare. I will provide proof of all vaccinations to Happy Tails Doggy Daycare.
6. I further understand and agree that in admitting my dog(s), Happy Tails Doggy Daycare has relied on my representation that my dog(s) is in good health and has not harmed or shown aggression or threatening behavior towards any other person or any other dog.
7. I further understand and agree that Happy Tails Doggy Daycare and their caregivers will not be held liable for any problems that might develop with my dog(s) including, but not limited to sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.
8. I understand and agree that any problem that develops with my dog(s) will be treated as deemed best by the caregivers of Happy Tails Doggy Daycare at their sole discretion and that I assume full financial responsibility for any and all expenses incurred.
9. The hours or operation of Happy Tails Doggy Daycare are 7:00a.m. to 5:30 p.m. ("closing time") Monday thru Friday (except statutory holidays). I agree that the management of Happy Tails Doggy Daycare retains the right to amend the hours of operation at any time.
10. Happy Tails Doggy Daycare fees and packages are non-refundable and non-transferable.
11. I agree that my dog(s) may be videotaped, photographed and or recorded. Happy Tails Doggy Daycare shall be the exclusive owner to the results and all proceeds of such media.
12. Happy Tails Doggy Daycare reserves the right to permanently remove a dog from daycare at any time.
